- Operator shall not set up without permit
- Operator shall display permit in an obvious location
- We do not provide or set-up equipment, such as tables, chairs or tents. Any color tents are acceptable.

  Ample weights are required on each leg of your tent (No staking/tying off to existing structures is allowed)

#### **FOOD TRUCK/BOOTH LICENSE:**

- Must have a valid State license with DATCP
- Licensure as a Transient Retail Food Establishment does not exempt an operator from licensure as a Mobile Retail Food Establishment

#### **INSURANCE:**

You are responsible for your own liability insurance within your rented area.

#### **WEATHER:**

- All operator applications must include a copy of your current Wisconsin Sellers Permit Number (Begins with a 456-xxxxxxxxxxx or 600-xxxxxxxxxxxx)
- Operator is responsible for collecting & paying state/county sales tax at 5.5% (Columbia County)
